
Trouble Shooting TXTREF2RIS

First, the references need to have no embedded tabs or extra spaces that have been inserted for APA indents or "outdents". They each just need to be entered from beginning to end with no hard returns, tabs, or extra spaces, letting WORD do the proper wraps for you by using the indent markers on the ruler line (see below).

As two incorrect examples, note the following references.


The first one can be corrected by placing your cursor after "maternal", then hitting "del", which yields this:

Lichter, D.T.& Crowley, M.L. (2004). Welfare reform and child poverty: Effects of

maternalemployment, marriage, and cohabitation. Social Science Research, 33, 385-408.

so you need to hit the spacebar between maternal and employment.

The Lichter reference looks good though, doesn't it? I recommend that to see if this reference (and the entire list) has incorrect spacing, when you paste it into a new blank document, you set it up in Landscape format (click File, Page Setup, Landscape.) In the case of the Lichter reference, you'll see this:



After you hit the deletes after "serial" and "honor of", it will look like this, which is what you want:

If you have a reference list with lots of hard returns, spaces or tabs inserted to "get it to look right" in APA style, you will need to manually correct the entire list as above BEFORE using TXTREF2RIS; otherwise it will fool my program and cause myriad problems. My macro "convertpdfref" (described in 4, and illustrated here) may be used to remove the majority of extra hard returns (but not the tabs and extra spaces).

As I said, the formatting (indenting or outdenting) should have been done by WORD automatically in the first place with the indent markers on the ruler line. Instead of THIS:

move either the top or bottom indent markers (depending on which version of the APA Manual you are complying with) like this:

which will turn a reference typed without hitting Enter (until the end) from looking like this:



Besides the issue of whether it is typed with extra spaces etc., TXTREF2RIS expects references to be typed with proper punctuation format, with all the commas, periods, spaces, etc. where they are supposed to be according to APA rules. That's how it knows how to parse (i.e., divide up the reference into its parts).

The proper format for a JOURNAL article, of course, is this:

Failure to have all this punctuation correct will result in TXTREF2RIS errors in the output file. Here are some examples. I give the faulty output first, then the faulty input that caused the problem.

Should be a comma, not a colon

Errors in input may be detected by scanning the output. Then either the OUTPUT may be manually corrected before importing it into your Reference Manager, or you may correct the input (for example, in the Jecker reference above, by replacing the colon with a comma), resaving the input txt file, then re-running TXTREF2RIS.
